### ARTICLES OF INCORPORATION

We, the undersigned, ith other persons being desirous of corporation for charitable and philanthropic purposes, under the previsions of Chapter 617 of the Florida Statutes, do agree to the following:

## ARTICLE I.: Name

The name of this corporation is JUNO ISLES CIVIC ASSOCIATION, INC.

## ARTICLE II.: Purposes

The general nature of the objects and purposes of this corporation shall be:

- A. To acquire, maintain, and conduct buildings and property for a community center, club rooms, reading rooms, and educational and recreational facilities, to acquire other properties, and to construct buildings for such purposes; to engage in any and all types of activities not prohibited by law which shall promote and foster better citizenship among its mambers, and which shall promote and foster educational, physical, and secial activities of its members and friends that they may acquire knowledge and understanding and good will among persons of all ancestries; to engage in such activities as shall raise the standards of civic morality and community welfare through educational, recreational, and social facilities, and to disseminate such knowledge as shall be useful for its members in their work and home life and as shall make them more proficient in their activities as citizens and residents of this state.
- B. In order to promote the purposes of this corporation, it may acquire property by grant, gift, purchase, devise or bequest, and hold and dispose of such property as the corporation shall require for the benefit of the members and not for pecuniary profit.

# ARTICLE III Qualification of members

The membership of this corporation shall equal late all persons hereinafter named as subscribers and other persons as, from time to time hereafter, may become members in the manner provided by the bylaws;

#### ARTICLE IV.: Term of Existence

This corporation is to exist perpetually.

## ARTICLE VIII.: Bylaws

# Upon Dissolution

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code, or to the Federal government, or to a State or local government, for a public purpose, and none of the assets will be distributed to any member, officer or trustee of this corporation.

## ARTICLE XII.: Indebt edness

The highest amount of indebtedness or liability to which the corporation may at any time subject itself shall never be greater than \$100,000 of the value of the property of the corporation.
