# ONLY TREES, LLC ADDITIONAL TERMS FOR SERVICE AGREEMENT

- 1. Work to be Performed. Only Trees, LLC is responsible for only providing the materials and performing the services described in this proposal and will attempt to meet all performance dates, but shall not be liable for damages due to delays from inclement weather or other causes beyond our control. Any additional services or material not described in this proposal must be agreed to by Only Trees, LLC and the property owner, or his agent, in a separate written proposal. This proposal is based on site conditions existing at the time of the quotation remaining unchanged and is valid for sixty (60) days from the date of the quotation.
- 2. Owner Permission. The property owner warrants that all trees, plant material and premises upon which work is to be performed are either owned by him/her or that permission for the work has been obtained from the owner. Only Trees, LLC is to be held harmless from all claims for costs, loss, damages, liability, expense, penalty or fine whatsoever resulting from the customer's failure to obtain such permission, including any such charges due to any suggested or actual violation or failure to comply with any laws, statutes, ordinances, and regulations issued by any private or public governmental body or subdivision.
- 3. Permits. (Select One) Property Owner Only Trees, LLC shall obtain applicable permits and licenses to perform the work described in this proposal, and such shall be responsible for all related fees, unless otherwise stated herein. If none is indicated above, the property owner shall be responsible for obtaining all permissions necessary for the work as provided for in the previous paragraph.
- 4. Utilities and Hidden Objects. The property owner is responsible for damage and injury resulting from damage to underground or any hidden/obscured service or other obstructions where their presence and route is not clearly marked and indicated to Only Trees, LLC, together with depth, height, nature of the hazard and dimensions. Charges received for the removal of power or telephone cables, services or infrastructures are the responsibility of the property owner, unless otherwise included in this proposal.
- 5. Indemnification. Unless otherwise provided for herein, each party ("first party") agrees that it will at all times indemnify and hold harmless the other party ("second party") from all losses, damage, liabilities and expense that may arise or be claimed against said second party and be in favor of any person, firm, or corporation, for any injuries or damage to the person or property of any person, firm, or corporation, occurring about or upon the premises on which this proposal relates related to or arising from the activities as set forth in this proposal related to or arising from any acts, omissions, neglect, or fault of said first party, his agents, servants, employees, licensees, customers, or invitees; or related to or arising from said first party's failure to comply with any law, statute, ordinance or regulation.
- 6. Terms of Payment. All accounts are payable upon receipt of invoice. If any accounts are not paid within thirty (30) days of the invoice date, such accounts will be considered overdue and subject to interest at a compound rate of 1% per week upon the balance outstanding. If outside assistance is used to collect the account, the customer is responsible for all costs associated with the collection, including, but not limited to, attorney fees and court costs.
- 7. Authority. Only contracts agreed with by an authorized Representative of Only Trees, LLC are Covered by this proposal.
- 8. ANSI A300 Tree Care Standard Definitions. The following definitions apply to specifications detailed in this proposal.

**clean**: Selective pruning to remove one or more of the following parts: dead, diseased, and/or broken branches. Unless noted otherwise on this proposal, all cleaning will be of branches 1 inch diameter or greater throughout the entire crown.

crown: The leaves and branches of a tree measured from the lowest branch on the trunk to the top of the tree.

leader: A dominant or co-dominant upright stem.

raise: Selective pruning to provide vertical clearance.

reduce: Selective pruning to decrease height and/or spread by removing specified branches.

**restore**: Selective pruning to improve the structure, form, and appearance of trees that have been severely headed, vandalized, or damaged.

thin: Selective pruning to reduce density of live branches, usually by removing entire branches.

vista pruning: Selective pruning to allow a specific view, usually by creating view "windows" through the tree's crown.

9. Returned Check Fees. There will be a \$25 fee for all checks returned to our office for insufficient funds.
